- abstracts typed in Microsoft Word 6.0 or newer version for Windows, \*.doc;
- abstracts must not exceed **3 pages** book-oriented A4;
- margins: left – **20 mm**, right, upper, lower – **15 mm**;
- Font – **Times New Roman 14pt**, line spacing – **1,5**, style – **Normal**;
- first line – full name of the author (font bold, italic, centered);
- second line – year of study, faculty, name of the university, scientific degree, academic rank, position, work place (italic, centered);
- next paragraph – title of the abstracts (font bold, centered);
- pages must not be numbered;
- text should be aligned in width;
- file name must match the full name of the participant;
- the topic of the e-mail must contain the full name of the participant and the note " for the conference".
